Alto Lakes Water & Sanitation District held a Regular Board Meeting on **Wednesday, May 18, 2016 i**n the Conference Room of the ALW&SD Office located at 214 Lake Shore Drive, Alto, NM 88312.

### **District Manager's Report**

## Water System Update:

District Manager Edington reported that the system is currently operating well with all production goals being met for Domestic and Irrigation demands. For April District Produced 11,827,100 gallons and we sold 10,275,800 gallons. Production VS Sold difference was 13.1% after leaks and flushing unaccounted for water 13%. Amount of unaccounted for water is relatively consistent month to month, but percentage of unaccounted for water varies greatly due to demand.

Number of active customers was down by 16, and consumption per active customer was down 100 gallons per active account from same time period last year.

### **Wastewater System Update:**

Manager Edington reported that the system is meeting required treatment goals at this time; however, it is still in violation of permit due to the discharge location.

#### **Solid Waste Update:**

Manager Edington presented solid waste pull statistics by Sierra Contracting for April 2016 to include 7 pulls with 210 yds of Green Waste of which 89% was yard waste and 11% was forest waste, with collection of \$774.20 in additional fees, 1 pulls with 8 tons of trash, 1 pull with 25 yds of cardboard, 1 pulls with 1 yd paper, 1 pull with 25 yds of miscellaneous with collection \$397.96 in additional fees, 1 pull = 30 yds metals (r/o not full ), 0 pull=0 yds plastics, and 0 pull=0 tons aluminum cans.
